Additionally, CICV monitors legislative and regulatory actions which affect the membership by a presence during the General Assembly sessions to review proposed legislation and interact with various administrative agencies. CICV is engaged in promoting the awareness of Virginia's independent colleges to potential students through publications and by sponsoring VA Private College Week. CICV also provides analyzed data to member institutions and appropriate state agencies to promote ventures where efficiencies can be achieved by the participation of a group of institutions. NAICU's 1,000 members nationwide reflect the diversity of private, nonprofit higher education in the United States. Members include traditional liberal arts colleges, major research universities, church- and faith-related institutions, historically black colleges and universities, women's colleges, performing and visual arts institutions, two-year colleges, and schools of law, medicine, engineering, business, and other professions.
