The RESCUE MISSION AND FAMILY SHELTER consists of a Transient program which provides temporary, short-term shelter for individuals as they develop a plan that will move them towards more long-term stability, a rehabilitation program which provides room and board, a small stipend, spiritual guidance through Chapel services, counseling, job and life skills training, a family shelter which provides emergency shelter for (30 to 90 days) for single women and women and children During their stay, clients are provided with food, shelter and clothing as well as spiritual counseling, life skills training and help connecting with community resources a single room occupancy provides room and board for the working poor, older men on social security and mental health clients, and community assistance provides food, clothing, furniture and funds for the needy The impact of these ministries was 223,902 meals served, 84,686 nights of lodging, 13,698 articles of clothing 356 boxes of food, and 2,140 children provided christmas
