**MEMORANDUM - HOW GRANTS RECIPIENTS ARE SELECTED:**

THE DECISION ON WHO IS TO RECEIVE FINANCIAL AID AND FOUNDATION GRANT MONEY IS MADE BY THE FINANCIAL AID COMMITTEE. PARENTS COMPLETE APPLICATIONS FOR FINANCIAL AID AND MAIL THEM DIRECTLY TO A FINANCIAL AID AGENCY IN NEW JERSEY. ALL INFORMATION IS CONFIDENTIAL AND ACTUAL NAMES ARE NOT DISCLOSED TO THE FINANCE COMMITTEE MEMBERS. THE AGENCY REVIEWS THE APPLICATIONS, PRINTS OUT A REPORT, AND FROM THAT, DETERMINES WHO MAY RECEIVE FINANCIAL AID. THE AGENCY THEN NOTIFIES THE ACADEMY ON WHO IS ELIGIBLE FOR FINANCIAL AID.

THE HEADMASTER GRANT MONEY MAY OR MAY NOT BE BASED ON FINANCIAL NEED. REQUESTS ARE MADE DIRECTLY TO THE HEADMASTER EITHER BY A WRITTEN LETTER OR AN ACTUAL INTERVIEW. THE HEADMASTER MAKES THE DECISION ON WHO WILL RECEIVE THE GRANT FUNDS.

SCHOLARSHIP AND MINORITY SCHOLARSHIP FUNDS ARE AWARDED TO INDIVIDUALS WHO MEET THE SPECIFIC GUIDELINES SET BY THE SCHOLARSHIP COMMITTEE. IT MAY OR MAY NOT BE BASED ON FINANCIAL NEED.
