Peace Plantation Animal Sanctuary (Peace Plantation), located 153 miles west of New York City, near Walton, New York is the National Humane Education Society's flagship animal care facility. Having become operational in 1950, Peace Plantation is one of a select few animal sanctuaries in the country that has withstood the test of time. During FY 2010, Peace Plantation worked to decrease animal suffering by reaffirming the intrinsic value of animal life through the provision of lifelong sanctuary and adoption services for a rotating average of nearly 300 animals a day—primarily cats and kittens, a few resident dogs, and various farm animals.

During FY 2010, Peace Plantation also provided humane education and animal rescue activities.
