Financial Education and Asset Building - The organization strives to enhance, through training, technical assistance and development of educational materials, the capacity of tribes, Native organizations and individuals to better manage their financial assets. Activities reflect the provision of instructor training workshops and follow-up technical assistance in asset building strategies and programs, participation in the Native Financial Education Coalition and their activities, and the development and distribution of new educational resources.

4b (Code:) (Expenses \$ 349,382 including grants of \$ 0) (Revenue \$ 363,549)

Entrepreneurship - The organization and eight regional partners are developing a regional entrepreneurship development systems model to assist Native Community Development Financial Institutions with providing intensive, long-term technical assistance and training, which their clients need, as well as assistance with entrepreneurial development. The Organization anticipates exporting this model to other communities.

Institutional Development - The primary goal is to help create, develop, expand and strengthen Native Community Development Financial Institutions (CDFIs.)
