Facts And Circumstances Test

Part II, Line 17a-- MusicLink Foundation became a charitable organization funded primarily by the general public and met the 33-1/3% test starting in 2009. In years 2005-2008, MusicLink Foundation received a large grant from a private foundation to assist MusicLink in increasing the number of states and teachers participating in MusicLink programs. The grants were \$50,000 in 2008, \$75,000 in 2007, \$37,500 in 2006, and \$112,500. This grant was not renewed for 2009.
