Richmond Ballet has become one of Richmond's finest arts and education institutions and gained national recognition as one of the country's premiere dance organizations. This year, over 24,000 Richmonders were entertained by three Studio Theater productions as well as Romeo and Juliet and the Nutcracker. The Ballet also performed at the Joyce Theater in NYC for the third time in 5 years.
