The Bridgeport High School Academic Boosters Corporation provides services and goods to benefit academics at Bridgeport High School. During the fiscal year 2009-2010, 49% of expenses were used to provide an ACT Prep Class (for which participants were assessed a fee), 48% to provide other services and goods to Bridgeport High School. The remaining 3% comprised administrative costs.
