Briefly describe the organization's mission

Founded in 1979 as the IntraH program at the University of North Carolina School of Medicine, IntraHealth incorporated as an independent nonprofit organization in 2003. IntraHealth's vision is a world where all people have the best possible opportunity for health and well-being. IntraHealth's mission is to enable health workers to better serve communities in need around the world. The organization fosters local solutions to health care challenges by training and supporting health workers, strengthening health systems, harnessing technology, and leveraging partnerships. IntraHealth has worked in more than 91 countries throughout its history, and has programs in over 30 countries in Africa, the Americas, Asia, and Eurasia.

Capacity Project. IntraHealth led the five-year, USAID-funded global Capacity Project (2004-2009), an initiative to strengthen the capacity of developing countries to plan, manage and support their human resources working within the health sector. IntraHealth strategies include improving workforce policies and practices, developing better educational programs and improving performance, productivity and retention of health workers. IntraHealth worked with foreign government agencies, private sector health providers, and civil society organizations. The project worked in 47 countries around the world.

Capacity Kenya. IntraHealth leads the five-year USAID Capacity Kenya Project (2009-2014), designed to work with the Kenyan government's health care leadership to improve their capacity in human resources for health (HRH). The goal of the program is to strengthen human resources for health systems of the public, faith-based, and private health sectors to ensure improved delivery to primary health care and, ultimately, to improve health outcomes of the Kenyan people. Key program interventions include HRH planning, policy, and practices interventions, health worker development interventions, and workforce performance systems to improve productivity and retention for delivery of HIV, family planning/reproductive health, maternal and child health, malaria and tuberculosis, services especially in underserved communities. The project also works with health sector leaders and stakeholders to determine creative and pragmatic approaches to incorporating community health workers into the health care system.

Namibia. IntraHealth leads the five-year, USAID-funded Capacity Namibia Project (2009-2014), designed to work with Namibian faith-based mission hospitals, nongovernmental organizations, and professional organizations to build HIV prevention, testing, care, and treatment capacity. The prevention efforts focus on students, community members, health workers, and pregnant women, and the treatment, care, and support programs focus on people affected by and infected with HIV. The project is also assisting the Namibian government to better manage its health workforce through implementation of a human resources information system, and to develop and support more social workers for the country's orphans and vulnerable children.
