Clinical Services United Family Services ("UFS") provided counseling to 8,162 individuals and families with 17,796 hours of counseling, 90% of whom said their counseling experience was helpful in addressing their problem and showed improvement in family functioning. Parenting education for divorced and separated couples was provided to 1,695 families, with 93% reporting increased confidence and competence in their parenting skills. UFS also provided Employee Assistance Program services to 1,588 clients in more than 50 local companies.

**4b** (Code ) (Expenses \$ 1,944,276 including grants of \$ ) (Revenue \$ 3,516,198 )

Victim Services United Family Services ("UFS") provides domestic violence services through several different programs that constitute a continuum of services for victims of domestic violence. Emergency shelter was provided to 562 women and children at The Shelter for Battered Women. 86% of these women reported that they were living without physical violence from their partner 6 months after leaving the Shelter. Victim Services also received over 15,500 calls for information and provided 516 outreach presentations to over 17,000 people. Program staff accompanied 4,263 clients to court to assist them in the restraining order process and provided counseling and educational groups to 1,339 women in the county jail. Victim Services offered professional support to 1,195 victims and family members of sexual assault and other violent crimes, served 155 rape victims in a hospital setting when they first arrived, answered 590 calls to its Rape Crisis Hotline, and provided educational sessions to 4,400 people. The Legal Representation Project affiliated with domestic violence services provided legal representation to 281 domestic violence victims through staff and volunteer attorneys.

Economic Independence United Family Services ("UFS") provided budget and credit counseling, mortgage foreclosure counseling, and reverse mortgage and bankruptcy counseling. UFS provided services to 5,500 families with this continuum of services, preventing 715 foreclosures, establishing 153 new debt consolidation plans, and providing 186 reverse mortgage counseling sessions to older adults.
