DURING THE FISCAL YEAR 2009-2010, WE PROVIDED HOUSING AND EMPOWERING SERVICES TO 122 FAMILIES, TOTALING 407 PEOPLE (144 PARENTS; 236 CHILDREN); 67% OF THE FAMILIES WHO COMPLETED THE PROGRAM MOVED SUCCESSFULLY INTO PERMANENT HOUSING.
