Since 1982, Child Care Resources Inc has been the driving force behind efforts to expand and improve early care and education and school-age child care services for families across the economic spectrum in the three-county region of Mecklenburg, Cabarrus and Union Counties Beyond its direct service area, CCRI also plays a critical role at the state and regional level by leading several key statewide initiatives, serving as one of three agencies that together lead the NC Child Care Resource and Referral Council, and tireless advocating for systemic improvements through an array of supportive services for young children and their families FY10 achievements (1) Child Care Financial Aid staff expensed approximately \$50 13 million in child care subsidy funds to the families of 12,497 children (monthly average of 8,148 children served), (2) Child Care Search parent counselors helped more than 6,668 families seeking child care on behalf of 8,920 children and assisted these parents with child development issues, and (3) Program and Business Consultation staff trained 80% of licensed child care programs in Mecklenburg, Union and Cabarrus Counties, delivering 2,084 training hours to 11,104 participants to increase their knowledge, build their skills and improve their services for more than 50,000 enrolled children (4) Program and Business Consultation staff delivered onsite assistance to licensed child care programs in Mecklenburg, Union and Cabarrus Counties, improving the quality of care for nearly 70,000 enrolled children
