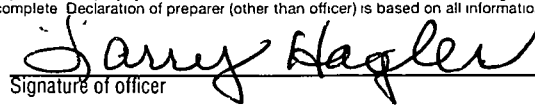

WE ALSO OFFER A CONNECTION GROUP- A SUPPORT GROUP OFFERED BY TWO INDIVIDUALS IN RECOVERY. THIS STRUCTURED GROUP OFFERS. THE ACHIEVEMENT OR OUTCOME REALIZED THROUGH THESE TWO PROGRAMS IS AN IMPROVEMENT IN THE QUALITY OF LIFE OF THOSE LIVING WITH MENTAL ILLNESSES- THEY LEARN TO MITIGATE OR PREVENT ALTOGETHER THEIR CRISES AND HOSPITALIZATIONS, THEY LEARN HOW TO ACTIVELY PARTICIPATE IN MAKING

THE OUTCOME ACHIEVED IS A SENSE OF BEING ABLE TO COPE- THAT WE ARE THERE TO HELP, AND AVAILABLE FOR CONSULTATION, INFORMATION, OR REFERRAL, OR JUST AVAILABLE TO LISTEN. WE SHARE INFORMATION ON RESOURCES, ANSWER QUESTIONS, LINK PEOPLE TO THE RIGHT PLACE, AND OFFER LOTS OF EDUCATIONAL INFORMATION ON DIAGNOSTIC CONDITIONS AND TREATMENT RESOURCES.
