ChildLinks (Child Care Resource and Referral) - Offers training, childhood resources, lending library, and information. Also, serves as the child care resource and referral regional lead agency. 623 Martin and Pitt County families searching for child care received child care referrals; 132 parents who received child care referrals received follow-up to assess referral services. 776 early childhood professionals from 219 child care facilities attended 91 trainings. 438 early childhood professionals and 105 parents have accessed resource centers 3,221 times to use early childhood books, videos, games, toys, die cuts, computer labs, lamination, and other equipment. 213 licensed child care centers and homes in both counties were listed with ChildLinks NACCRAware database for child care referrals. 91 centers and homes received short-term technical assistance.

Quality, Education, Support & Training (QUEST) - Promotes quality care through consultations, quality improvement plans, professional development plans, and grant awards in child care. 31 early childhood professionals in 11 centers & homes received assistance and training to increase the quality of child care for the 574 children enrolled. 49 child care professionals in 6 centers & homes received assistance and training to maintain the quality of child care for the 170 children enrolled. 81 teachers developed an education plan. 6 centers and homes submitted an application for a higher star license. 26 new/potential early childhood professionals received start-up consultations and assistance. 17 early childhood professionals in 8 infant/toddler classrooms received technical assistance. 6 directors received assistance for quality in child care administration. 3 home providers received specialized assistance for quality in home child care. 26 early childhood professionals from 8 classrooms participated in the "Positive Guidance" initiative to improve teacher-child interactions in the classroom environment.

Inclusion Specialist - Provides inclusion support for children with special needs and challenging behaviors in child care. 127 early childhood professionals from 33 facilities have received technical assistance. 1,339 total visits were conducted with participating early childhood professionals; 1 early childhood professional received intensive technical assistance (20 or more hours per week). 77 participating children were impacted by the facility's inclusion technical assistance plan; 45 (58%) had challenging behaviors. 12 children with developmental delays or challenging behaviors were in danger of being removed from their placement; 7 maintained their placements. 84 child care professionals attended 5 workshops/trainings; 22 parents attended 2 workshops.
