


More At Four Classrooms - Serve children who are at-risk and prepares them for success in school. 678 children received high quality pre-school education at no cost. There were 38 More at Four classrooms in 22 sites including Head Start, public school, and private licensed child care facilities. 35 of the 38 classrooms (92%) were in 4 or 5 star licensed facilities.

Child Care Resource & Referral - Provides assistance to parents who are looking for child care, and works to increase the availability, quality, and affordability of child care in the area. Initiatives include documenting service gaps, conducting market surveys, assisting new child care program operators, providing technical assistance with program start-up, building collaborations with providers and others to create or improve care, linking providers to training, offering training programs, encouraging accreditation, providing a resource lending library, and presenting data on the true cost of care. There were 835 parent referrals, 67 trainings conducted, 445 unduplicated providers trained, 476 on-site technical assistance visits, 36 child care facilities that received intensive technical assistance in an effort to increase their star rating to 3 or higher, and 13 child care facilities that received technical assistance in order to maintain a star rating of 3 or higher.

Program Coordination/Evaluation/Monitoring - Provides programmatic and fiscal monitoring and evaluation of in-house and sub-contracted activities to ensure activities are held accountable and achieving the set goals.
