 Senior Pharmassists helped 1280 individuals in the fiscal year ended June 30, 2010. We provided comprehensive services to 473
 participants (309 of whom received our financial assistance for needed medicines). Participants benefited from medication reviews
 with our clinical pharmacists, tailored health education and community referral, and help with selecting the most appropriate
 Medicare-approved drug plan for them for 2010. We also helped eligible participants apply for governmental subsidies to further
 reduce their medication expenses and furnished 19 individuals with incomes above 200% of the federal poverty level with
 medication reviews. Our program helped an additional 393 Medicare beneficiaries in Durham - regardless of age or income - with
 selecting the drug benefits that offered maximum savings while best meeting their needs. Finally, we provided 395 people with
 tailored referral to other medication assistance resources.
