**Harlem Academy is an independent school that prepares high-potential children from underserved neighborhoods for success at top secondary schools. Founded in 2004, the school has added a new grade for six consecutive years and now serves 86 students in grades one through six. Admission is selective and family partnership is required. No qualified family is ever turned away for financial reasons. Harlem Academy employs innovative features that set it apart from local public, charter, and parochial schools. The curriculum was developed in partnership with Columbia University's Institute for Urban and Minority Education. It is a rigorous program that includes more than five hours of academic instruction each day. The comprehensive program runs from 7:30 AM to 6:00 PM and includes arts, athletics, literacy, math, sciences, and character development from a team of two dedicated teachers working with an average class size of 15 students. Harlem Academy provides a unique environment where top academic performance is the norm rather than the exception. In 2010 standardized testing (ERB CTP4), the median Harlem Academy student performed at the 84th percentile nationally in English and math. Nearly two-thirds of students achieved at or above the 75th percentile, and one-quarter of students achieved at or above the 95th percentile.**

Since tuition is based off the financial ability of the family accepted, these contributions of either time or money have been crucial to the success of Harlem Academy in terms of meeting strict fiscal responsibilities, as well as laying out the roadmap for continued successful growth.**
