	Annually the Foundation processes over 21,000 gifts from 15,000+ donors. During the course of the year over 1,900 personal calls and over 1,700 personal visits were made by development staff on individual major gift donors. This is in addition to the thousands of contact and cultivations that are made at events held on and off campus during the year. The Foundation publishes an annual report and a web version is available for our donors, alumni, and friends of the School of Medicine and UNC Hospitals. In addition, three issues of the Medical Bulletin have articles on research projects, advances in medical care, and global projects that involve the School of Medicine. These publications serve to inform our donors and also cultivate their continued interest in supporting the Foundation. The Foundation has a longstanding recognition society that recognizes and stewards donors who annually support medicine at the level of \$2,000 per year. These donors receive invitations to events which include updates on the impact of gifts and the latest developments at the School of Medicine and UNC Hospitals. Endowment donors are sent annual financial reports that include information on the use of the prior year's income and recipients where applicable. The Loyalty Medical alumni fund produces an early case statement which includes fundraising results. The Medical Foundation has the fiduciary responsibility for administering over 1,100 separate funds composed of endowments, restricted and unrestricted funds. These accounts provide key support for research and patients. The support these gift funds provide is essential to the continued medical excellence of the UNC School of Medicine and UNC Hospitals. We are in regular contact with our account holders and provide them with reports on account activities including current balance and gifts credited.
