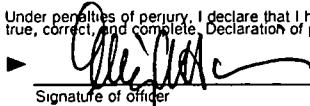

The financial statements are provided to the Board of Directors, Foundation and University Management, the University Internal Audit Department, as well as to the General Administration of the State of North Carolina.
