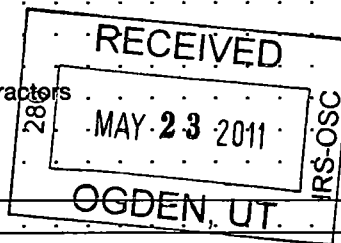



THE MINISTRY PROVIDES VARIOUS TRAINING PROGRAMS TO HELP PREPARE EXPECTANT MOTHERS FOR PARENTHOOD, INCLUDING A FINANCIAL EDUCATION AND PERSONAL BUDGETING "MOMMY BUCKS" PROGRAM AND A "CHARACTER POINTS" PROGRAM, BOTH OF WHICH HELP MOMS EARN POINTS WHICH CAN BE EXCHANGED FOR ITEMS FOR THEIR BABIES OR PERSONAL ITEMS FOR THEMSELVES. THIS HELPS THE BIRTHMOTHER BUDGET HER "MONEY" WHILE IN THE PROGRAM TO PREPARE HER FOR MANAGING HER FINANCES WHEN SHE LEAVES THE MINISTRY. TRAINING INCLUDES CHILDBIRTH CLASSES, PARENTING SKILLS, NUTRITIONAL SKILLS, AND HOUSEHOLD/FINANCIAL MANAGEMENT SKILLS. MOTHERS RECEIVE BIBLICALLY-BASED COUNSELING TO HELP THEM WORK THROUGH THEIR CRISIS SITUATIONS, AND TO HELP THEM DECIDE WHETHER TO PARENT OR TO PLACE THEIR BABIES FOR ADOPTION. FAMILY MEMBERS ALSO RECEIVE COUNSELING SERVICES.

CLIENTS ARE REQUIRED TO CONTINUE THEIR EDUCATION WHILE STAYING AT THE HOME. THE MINISTRY HAS ESTABLISHED A LEARNING CENTER IN THE BASEMENT OF THE LEASED RETAIL BUILDING NOTED IN PROGRAM SERVICE ACCOMPLISHMENT #4. THE LEARNING CENTER INCLUDES A COMPUTER LAB. A PROGRAM FOR CAREER SKILLS TRAINING AT THE RETAIL STORE HAS BEEN IMPLEMENTED. TUTORING SERVICES, TRANSPORTATION TO SCHOOL, AND EDUCATIONAL MATERIALS ARE PROVIDED BY THE MINISTRY. ONE CLIENT ACHIEVED HER EDUCATIONAL GOALS DURING THIS TAX PERIOD BY COMPLETING THE GED.

THE MINISTRY CONTINUED TO OPERATE "THE SECRET PLACE" RETAIL STORE, WHICH SELLS USED CLOTHING AND ACCESSORIES THAT ARE DONATED TO THE MINISTRY. THE MINISTRY SUBLEASES SPACE IN PART OF THE BUILDING, CALLED "THE ALCOVES OF A PLACE FOR US MINISTRIES", TO PRIVATE VENDORS TO HELP COVER THE LEASE COST. THE INCOME AND EXPENSE FOR "THE ALCOVES" IS REPORTED ON FORM 990-T.
