Brenau University is a private comprehensive university that includes the Undergraduate School, the Graduate School, and the Academy. Each component of the University enhances the others through shared resources, facilities, faculty and cultural opportunities with some limited cross-enrollment opportunities available. However, each unit is defined by distinct characteristics. The Undergraduate School offers studies leading to an associate degree and 40 baccalaureate degrees and is open to men and women. The programs provide foundations for individual and professional growth and competence. Within the Undergraduate School is the Women's College, which offers baccalaureate programs, some of which feed into graduate programs, with a multi-discipline liberal arts foundation that enable students to explore general interests as well as pursue specialized studies. The Women's College is a residential institution which also provides for enrollment of non-residential female students. Enrollment for the Women's College is 840 students.

The Graduate School offers studies leading to 27 masters and educational specialist degrees as well as 5 graduate certificates and is open to men and women. The programs encourage students to develop the proficiency and professionalism necessary to meet the challenges inherent in their fields of study. The combined enrollment in the coeducational Undergraduate and Graduate Schools is 1,900.

The Academy is a college preparatory boarding and day school for young women in grades nine through twelve. Among the many educational opportunities available to Academy students is the chance to take college classes and earn college credits through the Women's College. The Academy enrollment is 48.

Therefore, the University has concluded that no tax benefits or liabilities are required to be recognized. Generally, the IRS may examine a tax return for three years from the date it is filed. At June 30, 2010, tax years ended June 30, 2009 and 2008 and 2007 remain open for possible examination by the IRS.
