Guilford Day Reporting Services Program - This program offers services for male offenders 16 to 25 years old. It is designed to educate, treat, monitor, and supervise them to decrease the possibility of their re-offending. Services include on-site substance abuse evaluation and treatment recommendations, adult basic education and GED preparation, career development and job placement assistance, anger management, and referrals to human resource agencies that can assist the offenders to become self-sufficient. Judges sentence eligible offenders to the Day Reporting Services Program. Pre-trial Release Resource Program - This program offers services for offenders 16 years of age and older that have been released from jail, but are still awaiting trial. Services provided include attitude orientation and other related classes.
