NATIONAL FOUNDATION FOR TRANSPLANTS (NFT) HELPS PATIENTS RECEIVE LIFESAVING TREATMENT, MEDICATIONS AND LONG-TERM CARE THEY OTHERWISE COULD NOT AFFORD. NFT ASSISTED MORE THAN 1000 patients with financial support, mobilized 310 new community FUNDRAISING CAMPAIGNS, AND COUNSELED AND SHARED RESOURCE MATERIALS WITH MORE THAN 1400 ORGAN AND TISSUE TRANSPLANT PATIENTS AND THEIR FAMILIES. NFT PROVIDED PATIENTS WITH MATCHING INCENTIVE GRANTS, BONE MARROW DONOR SEARCH GRANTS, LIVING DONOR ASSISTANCE AND EMERGENCY NEED GRANTS. NFT's Transplant Challenge program is a health awareness campaign designed to increase the number of registered organ donors. There are currently more than 108,000 patients awaiting transplants in the United States. While 90 percent of Americans say they support organ donation, only 37 percent of licensed drivers have officially registered as donors. The Transplant Challenge is an effort to educate Americans about the nation's severe organ shortage and encourage individuals to register as donors. The Transplant Challenge has reached more than 25,000 individuals with messages about the importance of organ donation and assisted in registering 508 new organ donors with their state donor registries.

NFT's Home Away from Home Program provides patients and their caregivers with free lodging when transplant-related medical care makes travel necessary.
