Wellstar Foundation is the development and fund-raising center for Wellstar Health System, an organization described in IRC Section 501 (c) (3). It is dedicated to serving our community and giving people the tools and facilities to become stronger and healthier. The members of the Foundation collaborate with other community leaders to raise funds and provide programs and services which result in health improvements for all. Payments to hospital projects for the reporting period exceeded \$4 million. Health, Safety & Education: Wellstar Foundation continues to have initiatives for fundraising that will help to improve the health of children and families in the Wellstar service area with an emphasis on some of the following service lines and disciplines--cancer, cardiac, end-of-life, prevention & wellness, and overall facilities improvements. Over the past five years Wellstar team members have donated \$2.8 million towards system initiatives through the annual employee giving campaigns. The employees of the Wellstar Administration Building gave \$97,000 during the reporting period to assist in enhancements in the cancer program including new technology. Other programs and facilities enhancements benefiting from the generous support of donors in the community include: Hospice--funds for a new inpatient facility near the Kennestone Hospital campus as well as funds donated to help hospice patients needing assistance. Cardiac Services--A new chest pain observation unit, a cardiac health promotion project and more specialized cancer treatment technology. Cancer Services--STAT Cancer Clinic and I-ELCAP program, genetic risk assessment counseling and specialized equipment for the oncology department. Women's Services--instead of one annual Speaking of Women's Health event to raise awareness of women's health issues there are several workshops on a variety of topics throughout the year and new NICU equipment. Community Outreach--School health and Cobb Safe Kids programs, a state-funded "First Steps" program for expectant mothers and their families, scholarships and financial assistance for residents of the assisted living facility on the Kennestone Hospital campus called Atherton Place. General Facilities Improvements--equipment and facility funds have been raised for a variety of projects across the Wellstar system including \$56,000 for Paulding Hospital renovations and new facilities as well as \$49,000 for Windy Hill Hospital renovations. Funds totaling \$115,000 were raised in support of construction of the Lipson Center at Kennestone Hospital which is named in memory of a former CEO of Wellstar Health System.

Wellstar's executive compensation philosophy defines the market as being comprised of comparable not-for-profit health care delivery systems, i.e., not-for-profit organizations similar in complexity and scale to Wellstar. To assist the committee in fulfilling its duties, the committee engaged the Hay Group to provide market compensation data to compare to the Wellstar positions whose compensation the committee oversees. The committee uses this data to provide context when making decisions in administering the compensation program. Accurate minutes of the committee's discussion and decisions are recorded during each committee meeting, and reviewed and approved at the following committee meeting.
