**OUR ECE PROGRAM AIMS TO ENSURE THAT CHILDREN ARE MEETING THEIR DEVELOPMENTAL MILESTONES AND ARE PREPARED FOR THE NEXT LEVEL OF LEARNING. WE SERVED A TOTAL OF 157 CHILDREN FROM 110 FAMILIES. OF THESE FAMILIES, 91% WERE SINGLE-FEMALE HEADED HOUSEHOLDS, 8% WERE TWO-PARENT HOUSEHOLDS, AND 1% HAD A SINGLE-MALE HEADED HOUSEHOLD. THE MAJORITY OF FAMILIES WE SERVED WERE AFRICAN AMERICAN (90%), WITH THE REMAINING BREAKDOWN AS FOLLOWS: 3% HISPANIC/LATINO, 5% CAUCASIAN, AND 2% OTHER/BIRACIAL.**
