It was a very good year. In January 2009, we undertook a strategic planning process which was very productive. In our planning, we surveyed our donors and members and got very positive feedback. We also specifically decided to focus on conservation, education, recreation and restoration of the river.

We decided to become an accredited land trust with a niche in riparian buffer area of under 100 acres. No land trust in the entire state has this focus, and we felt it was very important that these ecologically sensitive areas be protected in perpetuity. We also undertook a number of stream restorations. We continued our education in the school program and reached a record number of children with our hand-on learning opportunities. We continue to harness the energy and creativity of volunteers and now have close to 500 active volunteers helping us with everything from litter clean ups to office work and trail maintenance.

In 2010, we received a \$50,000 grant to commence our conservation land trust accreditation process. We have gathered all the materials we will need to create for accreditation. We have also interviewed a consultant to help us through that process.

Another huge accomplishment is we were awarded a \$187,000 grant from the Clean Water Management Trust Fund to make the final payment at Karen Cragolin park.

We have been fortunate to work with AmeriCorps volunteer members who have helped us enormously by adding capacity to our organization but not much overhead.

We are remediating a Brownfield and did receive funds to conduct clean up at one of our recent purchases a former junk yard. This project is receiving the benefit of \$317,000 in Stimulus Funds to conduct a phytoremediation Brownfield clean up as a demonstration project for the watershed. We will be working with local technical school to create a niche market for phytoremediation native plants. Ultimately, this property will be given to the people of the region when the cleanup is complete as a new addition to the greenway system in Asheville.
