28 2010 was the organization's 14th anniversary. The theater worked on development of its international outreach program, The Portal Project, with artists in Berlin, Germany. As a result they co-created and performed three shows in Berlin with parnter theater Ballhaus Ost. Their 2009-2010 show 101 Humiliating Stories was named as one of Atlanta's Top 50 plays of the decade by Creative Loafing and commissioned for a remount in 2011 in a partnership with Synchronicity. Under the adult education program they had six nationally recognized artists from outside of Atlanta perform and give workshops. PushPush served over 350 artists in 2010 with affordable space and workshops, and opportunities for career advancement and performance. Through this work they connected 6000 live audiences to innovative and diverse performances and programs that provided education, entertainment, and artistry.
