During the 2009 Tax year, the Gift Stop provided \$92,708 of support to Shands Hospital at UF, the University of Florida Medical Guild, the Shands Hospital Auxiliary, and the Florida Veterinary Medicine Faculty Association. The Shands Auxiliary operates to provide support to Shands Hospital at UF. The UF Medical Guild provides support and grants to students and departments of the J. Hillis Miller Health Science Center and to areas of Shands Hospital at UF. The Florida Veterinary Medicine Faculty Association operates to support the delivery of animal health care in an academic setting, provide veterinary education at UF, and improve veterinary medicine and education and research at UF. Shands Hospital at UF, the Shands Auxiliary, the UF Medical Guild, and the Florida Veterinary Medicine Faculty Association are tax exempt organizations.

The Board of Directors annually distributes a portion of net profits to supported organizations. Shands Teaching Hospital and Clinics (d/b/a Shands Hospital at UF) receives 25% of net profits. Shands Hospital shall have full discretion in the use of funds received. A portion of net profits is held in a contingency fund for current and future shop development. The remaining portion of net profits is allocated to owner groups of the Gift Stop. Owner groups of the Gift Stop are the University of Florida Medical Guild, and the Shands Auxiliary. During the 2009 tax year, members of the Gift Stop with ties to the Veterinary School, decided to allocate \$10,455 to the Florida Veterinary Medicine Faculty Association. The Florida Veterinary Medicine Faculty Association is a tax exempt organization dedicated to supporting the College of Veterinary Medicine at the University of Florida. The College of Veterinary Medicine is a division of the UF J. Hillis Miller Health Science Center. The University of Florida Veterinary Guild, which would normally receive this distribution, is no longer active.

All organizations receiving a portion of the Gift Stop's net profits are tax exempt organizations. The University of Florida Medical Guild is a supporting organization that provides grants to areas of Shands Hospital at UF. The Medical Guild also provides scholarships and grants to students of the J. Hillis Miller Health Science Center enrolled in various Health Science education programs at the University of Florida. The Shands Auxiliary is also a supporting organization that provides grants to areas of Shands Hospital at UF.
