youngARTS is NFAA's core program. It provides recognition and awards to young artists across the country. NFAA is the only organization that encourages and recognizes artistic excellence in the literary, visual and performing arts, including dance, cinematic arts, jazz, music, photography, theater, voice, and writing. Each year, approximately 6,000-8,000 students register for the youngARTS program and approximately 500 students receive cash awards.

youngARTS/New York is a unique regional program created by the National Foundation for Advancement in the Arts (NFAA) and is an additional benefit of applying to the youngARTS program. youngARTS/New York encourages and supports the most promising artists in New York City during their senior year in high school. As a regional program underneath the umbrella of the youngARTS national program, youngARTS/New York is designed to give New York City's most talented young actors, dancers, filmmakers, musicians, photographers, visual artists, vocalists, and writers the opportunity to receive financial support, scholarship assistance and artistic guidance from some of the most renowned artists in their own backyard.

Each year, 20 youngARTS Finalists are named Presidential Scholars in the Arts. At the request of The Commission on Presidential Scholars, which is appointed by the President of the United States, National Foundation for Advancement in the Arts, through its youngARTS program serves as the exclusive nominating agency for Presidential Scholars in the Arts. Participants in the youngARTS program are the only students eligible to receive the designation of Presidential Scholars in the Arts (PSA), based on their artistic and academic achievements. Being named a Presidential Scholar is the highest scholastic honor available to graduating high school seniors. Each year, a group of 60 PSA nominees are selected from the 150 youngARTS Finalists. From these students, 20 winners are chosen by the Commission on Presidential Scholars and named Presidential Scholars in the Arts, alongside 120 academic scholars at a White House ceremony. In addition to this once in a lifetime honor, the visual artists, photographers and writers present their work in an exhibition at the Smithsonian Museum, and the performing artists perform at the John F. Kennedy Center for the Performing Arts, truly a life changing experience for any young artist.
