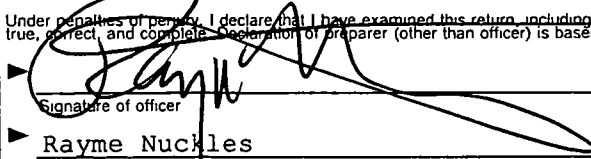

Homeless Prevention and Rapid Re-housing program provides financial housing
assistance to households at risk of becoming homeless or are currently homeless
whose income is at or below 50 percent of AMI. As such, this provides relief
to poor households. Additionally, these households are provided with case
management and other supportive services needed to help them become self-sufficient
and to maintain permanent housing. The more people who become able to maintain their
housing, lessens the burden on government mainstream programs, such
as Medicaid, food stamps and temporary aid to needy families.

UNITY Information Network- works to provide relief to the poor through the
collection of data on homelessness in our community. This data is then used in planning new
programs and expanding existing programs to provide housing and supportive
services to homeless families and individuals. The data is included in
applications for funding these types of programs at all levels of government
and private organizations.

Outreach for Life program provides relief to the poor through access to
needed healthcare services. Most homeless people lack this access, as the
Medicaid program does not cover single men. Poor health is often a barrier to homeless people
being able to overcome their situation because of fatigue, chronic hospitalizations
and symptoms of disease consume much of their time. Helping address their
physical and mental health needs, homeless people are better able to participate
in housing and supportive service programs which will help them get off the streets
and into better housing.

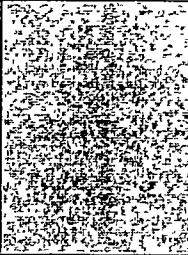
