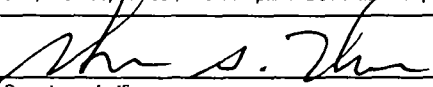
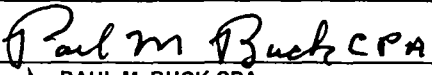

Procedures for selection of Scholarship recipients

The Foundation chooses 3 club members each year to serve and review applications from regional secondary schools for college scholarships.

The committee members independently review the applications considering Class rank, strength of schedule, extra curricular activities, and financial need.

The committee then meets and reduces the potential number of recipients to 10 (if necessary), and recommends to the club members, those candidates chosen. The scholarships are usually in the amount of \$1,000.
