When Catholic Health Initiatives (the ultimate parent organization to Flaget Memorial Hospital) established its charity care policy it was determined that establishing a household income scale based on the HUD very low income guidelines more accurately reflects the socioeconomic dispersions among the 69 urban and rural communities in 19 states served by CHI hospitals and health care facilities. In comparing HUD guidelines to the Federal Poverty Guidelines ("FPG"), we find that on average HUD guidelines compute to approximately 200% to 250% (and sometimes 300%) of FPG. Flaget Memorial Hospital ("Flaget") bases its eligibility for charity care on the HUD Geographic Very Low-Income Guidelines, Medical Necessity (determined by patient medical history, Physician's order and/or medical documentation), available assets and any extenuating circumstances. Medical Necessity is defined as services or items, reasonable or necessary, for the diagnosis or treatment of illness or injury or to improve the functioning of a malformed body member. Medical Necessity is determined on a case-by-case basis. An individual's income under the HUD guidelines is a significant factor in determining eligibility for charity care. However, in determining whether to extend discounted or free care to a patient, the patient's assets may also be taken into consideration. For example, a patient suffering a catastrophic illness may have a reasonable level of income, but a low level of liquid assets such that the payment of medical bills would be seriously detrimental to the patient's basic financial (and ultimately physical) well-being and survival. Such a patient may be extended discounted or free care based upon the facts and circumstances.

Flaget Memorial Hospital's debt collection policy provides that Flaget will perform a reasonable review of each inpatient account prior to turning an account over to a third-party collection agent and prior to instituting any legal action for non-payment, to assure that the patient and patient guarantor are not eligible for any assistance program (e.g. Medicaid) and do not qualify for coverage through Flaget's community assistance policy. After having been turned over to a third-party collection agent, any patient account that is subsequently determined to meet the Flaget community assistance policy is required to be returned immediately by the third-party collection agent to Flaget for appropriate follow-up. Flaget requires its third-party collection agents to include a message on all statements indicating that if a patient or patient guarantor meets certain stipulated income requirements, the patient or patient guarantor may be eligible for financial assistance. All of Catholic Health Initiatives' hospitals' contracts with third party collection agencies include the following standards: - Neither CHI hospitals nor their collection agencies will request bench or arrest warrants as a result of non-payment, - Neither CHI hospitals nor their collection agencies will seek liens that would require the sale or foreclosure of a primary residence, and - No Catholic Health Initiatives' collection agency may seek court action without hospital approval. Finally, collection agencies are trained on the Catholic Health Initiatives Mission, Core Values and Standard of Conduct to make sure all patients are treated with dignity and respect.

The Sisters of Charity of Nazareth, along with civic leaders and local physicians, wanted to respond to the health care needs of the residents of Nelson County, Kentucky and surrounding geographic areas. Since its inception, Flaget Memorial Hospital ("Flaget") has embraced the mission of the Sisters of Charity of Nazareth to provide healthcare as a continuation of the healing ministry of Jesus, which means a preferential option for the poor and vulnerable among us. This tradition has been complemented and enhanced with Flaget's membership in Catholic Health Initiatives and now as members of Saint Joseph Health System. The mission of Flaget Memorial Hospital, Saint Joseph Health System and Catholic Health Initiatives is "to nurture the healing ministry of the Church by bringing it new life, energy and viability in the 21st century. Fidelity to the Gospel urges us to emphasize human dignity and social justice as we move toward the creation of healthier communities." Catholic Living our Mission and Core Values Health Improving the health of the people and communities we serve Initiatives Pioneering models and systems of care to enhance care delivery Flaget Memorial Hospital's vision is to live out our Catholic identity through the integration of our mission and core values, improve the health of the communities we serve, and pioneer models and systems of care to enhance care delivery. Our community benefit efforts flow naturally from our mission statement and core values. We work with our federal and state government participating in programs such as Medicare and Medicaid. The programs and services described throughout this report not only serve the community, but also reduce the burdens on the government. For example, if Flaget Memorial Hospital did not serve all people in need and provide charity care, the burden would likely fall on tax supported institutions.

COMMUNITY BENEFIT APPROACH Our charitable purpose, our true motivation, is found in fulfilling our collective calling to serve the healthcare needs of all people regardless of their social or economic standing. This commitment is displayed throughout Flaget's operations, including our Emergency Department, which is always open to care for people who do not have a means to pay. The Flaget Immediate Care Clinic is a designated rural health facility that provides corporate health services, walk-in sub-emergent care, and primary care. Our primary care physician located in the Immediate Care Clinic predominately treats patients that are either self-pay or qualify for Passport, a Medicaid servicer. Prior to Flaget providing primary care through the Flaget Immediate Care Clinic, patients who qualified for Passport often did not have a primary care physician because such practices were closed to Passport patients. Flaget recognized this substantial unmet need, and found a way to meet that calling in the community through the Immediate Care Clinic. We are proud that the services we provide to our community have expanded over the years as we have grown into a comprehensive healthcare provider. We compliment our ability to offer the latest technology with a personal and compassionate touch. Thomson Reuters has noted our excellence in healthcare naming Flaget Memorial Hospital as one of the top 100 hospitals in the United States for four consecutive years. As an organization, we recognize that the practice of Catholic healthcare calls us to serve the entire human person. Therefore, the services we offer our community not only meet our patient's physical needs, but also their psychological, spiritual, educational and social needs. For patients who cannot afford to pay for their care, we have stated policies that allow us to offer financial counseling and assistance through our charity care programs. Our most recent effort to expand the services to our community is the Flaget Cancer Center. Before the Flaget Cancer Center, patients suffering from cancer who required radiation therapy had to travel a minimum of 45 miles in order to receive cancer treatment.

QUALITATIVE DESCRIPTION OF COMMUN ITY BENEFIT

Prescription Assistance Program The Flaget Prescription Assistance Program see ks to build a healthy community by assisting people who are having difficulty paying for t heir non-narcotic prescription drugs This service is available to everyone in our communi ty and utilizes programs through the pharmaceutical companies that allow people to receive long-term medications at little or no cost However, the pharmaceutical company programs have limitations It can be difficult for a patient to find the correct application form, the forms are complex and vary company to company, making them difficult to complete Furt hermore, even when a patient qualifies for these programs, it can take up to 8 weeks to be gin receiving medications During the waiting period, the patient is responsible for the c ost of the medication To address these concerns, Flaget hired a part-time social worker w ho has expertise with the available programs and is available to walk patients through the application process and maintain on-going paperwork Additionally, to bridge the gap betw een when a patient applies for medication, and when a patient receives the benefit, we hav e created a voucher system that makes funds available to the patients so they can immediat ely receive the prescriptions needed This past fiscal year our Prescription Assistance Pr ogram granted over \$833,000 in free prescriptions for our community Food Drive and Christ mas Sponsorship We partner with local social service organizations and organize a hospital food drive and Christmas sponsorship for individuals and families in need over the holida ys

Health Screenings The Flaget Health Connection is open to provide regular health scree nings for the community Partnering with organizations such as the Kentucky Department of Highways, we offer health screenings, which include blood pressure checks, blood sugar che cks, prostate screenings, and cholesterol testing at various sites in the community

Healt h Education and Wellness Our Flaget Health Connection serves as a community resource for a nyone in need of information on healthy living and managing illness The program also coor dinates a "Trim Down Bardstown" event, which works with community members to achieve weigh t-loss goals We regularly attend community-wide events and provide health information and needed first-aid care at events such as the Bourbon Festival, the Salt River Electric Pic nic, and My Old Kentucky Home Bike Tour

In July 2008, Flaget Memorial Hospital joined 7 other Kentucky facilities to become Saint Joseph Health System Kentucky (SJHS Kentucky). Flaget Memorial Hospital and SJHS Kentucky, along with its affiliated outpatient facilities, are part of Catholic Health Initiatives. Catholic Health Initiatives (CHI) is a national faith-based nonprofit health care organization with headquarters in Englewood, Colorado. CHI's exempt purpose is to serve as an integral part of its national system of hospitals and other charitable entities, which are described as market-based organizations, or MBOs. An MBO is a direct provider of care or services within a defined market area that may be an integrated health system and/or a stand-alone hospital or other facility or service provider. CHI serves as the parent corporation of its MBOs which are comprised of 73 hospitals, 40 long-term care, assisted- and residential-living facilities, and two community health-services organizations. Together, these facilities provided \$590 million in charity care and community benefit in the 2010 fiscal year, including services for the poor, free clinics, education and research. CHI provides strategic planning and management services as well as centralized "shared services" for the MBOs. The provision of centralized management and shared services - including areas such as accounting, human resources, payroll and supply chain -- provides economies of scale and purchasing power to the MBOs. Cost savings associated with centralized services for the fiscal year ended June 30, 2010 include more than \$105 million in supply chain expense, approximately \$30 million for insurance costs and more than \$3.9 million as the result of a system-wide effort to coordinate and negotiate technology and equipment purchases. The cost savings achieved through CHI's centralization enable MBOs to dedicate additional resources to high-quality health care and community outreach services to the most vulnerable members of our society.
