Through a contract with the California Public Utilities Commission (CPUC), CCAF provided specialized
telecommunications equipment to over 132,000 new deaf and disabled consumers through oversight of a centralized
call center, which received over 192,000 calls annually. CCAF also provided specialized equipment to over 26,000
consumers in their homes or in eight Service Centers throughout California. Through its contract with the CPUC,
CCAF also managed contracts with the California Relay Service vendors, who relayed over 2,234,000 calls to and
from deaf, hard of hearing, and speech disabled users.
