Undergraduate Programs. Trevecca offers 53 undergraduate majors and 4 associate degree majors in 10 departments and 4 schools: Business, Education, Religion, and Arts and Sciences. Trevecca also offers degree-completion programs in criminal justice and information technology. A combined total of 1,298 students were enrolled in the traditional undergraduate and non-traditional undergraduate programs in the fall semester of 2009.
