The funds raised by the Foundation allow Memorial to extend its mission of medical excellence further into the community. The Foundation has a governing Board comprised of community representatives that represent the diverse populations within the Chattanooga area. Community Benefit In FY 2010, the Foundation raised funds through special events, annual giving, major gifts, planned giving, corporate/foundation grants and capital campaigns to fund capital equipment, provide medical services to underserved populations, support community outreach programs, scholarships to students pursuing health care careers, and an endowment fund. In FY 10, the Foundation raised 1.9 million for these purposes and disbursed 1.17 million to support Memorial Health Care System nonprofit health care services. Since its inception, the Foundation has raised 13.3 million and disbursed 10.5 million to support Memorial Health Care System's mission. Community services have always been a significant part of Memorial Healthcare System. Each year, services and programs offered to the community are evaluated and expanded to promote both increased access to healthcare and healthier communities. To enhance the health status of Chattanoogans, Memorial focuses on the whole person including the person's spiritual, emotional, and physical well-being. Highlighted below are some of the programs or capital expenditures that have been made possible through funding from the Foundation.</p> <p>Westside Clinic: An anonymous donor wanted to make a difference in the lives of our patients who seek their healthcare services from one of Memorial Health Care System's clinics. She gave \$150,000 to the Foundation and allowed the clinic staff to determine how the funds could best be used to help their patients. Westside Health Center is located in the "Homeless-Chattanooga HPSA ID # 1479994782." Westside Clinic serves the College Hill Courts, a 500 unit intercity housing development and Boynton Towers, a 250 unit low income housing for seniors. The current percentage of residents 65+ is 21.9% compared to the national average of 12.7%. Median household income is \$11,259 compared to the national average of \$50,152 and Tennessee income of \$42,144. Westside Clinic saw 1,367 patients in 2008 and 1,776 in 2009 for a 29% increase in services. The clinic accepts patients regardless of their ability to pay. The donor's funds pay for a Nurse Practitioner who focuses on patients diagnosed with diabetes. Breast MRI and the Mary Ellen Locher Breast Center: Memorial Hospital was able to centralize and expand their Breast Service program totally through donations received through the Foundation. In the past few years, the Foundation raised 4.2 million to purchase a dedicated Breast MRI and build the Mary Ellen Locher Breast Center, a state of the art breast center offering mammograms, ultrasound, stereotactic procedures, bone density, exam rooms, and infusion services. The Foundation also assists the hospital in obtaining grants to fund breast services and education to underserved women. In 2010, the Chattanooga affiliate of the Susan G. Komen Breast Cancer Foundation, Inc. awarded several grants to Memorial Hospital. One grant provides underserved women with access to mammograms. Memorial Hospital hosted 88 Breast Health Programs and participated in health fairs, to distribute educational material, provide presentations and individual education to 5,741 diverse groups of women, including homeless women in shelters and public housing facilities. All women who participated in the Access to Mammograms' program received a clinical breast exam, mammogram and many attended educational sessions. In FY 10 of the 2,653 women participating in the outreach breast cancer screening programs, 112 received abnormal mammogram results and 11 of these women were diagnosed with breast cancer. Avon Foundation Breast Care Fund has awarded a grant to Memorial Hospital to fund outreach efforts to women age 40 and over who are not involved in a breast health care plan. A part of this program includes 'Shopping for Breast Health' which provides health oriented products and educational materials to women. The grant also provides funding for a full time outreach coordinator and one part time assistant and incentives to encourage women to attend the educational/screening programs.</p>

Breast Services also offers Cancer Risk Counseling to help people understand better how their family history of cancer might affect their individual risk of developing cancer. Accurate educational information and individual counseling is provided at no charge to the patient which was made possible through grants and donations from the Foundation. All women are provided breast screening services regardless of their ability to pay through Memorial Health Care System. The grants we discussed above only cover a portion of the costs incurred by the hospital to provide breast related services. The rest of the cost is covered through hospital funds as a community benefit. The Foundation's support of the hospital allows the hospital to provide more community benefit programs than they would otherwise be able to provide. Once diagnosed with cancer and in treatment we continue offering support to our uninsured and underserved ladies by providing post education and navigation through treatment, mastectomy products and accessories to look your best when experiencing the side effects of treatment with hair loss at no cost. Hand-made hats and heart shaped pillows are donated from community organizations and ladies groups. We accept gently used mastectomy products, clean them and offer them to ladies who otherwise don't have access. A 55 year old woman, who had lost her hair during treatment, came in to look at the wigs with tears in her eyes and found a wig. She said she had a friend who would style it for her.</p>

Whether you have just been diagnosed or have a family member with cancer, the oncology professionals at the Cancer Resource Center can answer your questions or help you understand your options regardless of where you go for treatment. You can learn about financial resources, screening opportunities, the most current clinical trials, and support groups and seminars offered to patients, family, and friends. The Cancer Resource Center also offers professionally led support groups, children's program, CLIMB (Children Living In Moments of Bravery), and We Care Week-end, a family retreat for cancer survivors. None of the services are billed to the patient and few qualify for insurance reimbursement. In FY 2010 the cost of this program was \$368,663. Donations for Cancer Resource Center have help offset these costs. Cancer Institute In FY 10, a complimentary weekly program for recently diagnosed cancer patients began. Living Well with Cancer is an introduction and tour of support and treatment services available to MHCS patients. Logistics, such as parking, appropriate entrance for services, food service, and location of the chapel and outpatient pharmacy are addressed. Each participant determines their stress level and then meets a social worker to discuss stress. They also meet oncology nutritionists, nurse educators and the oncology chaplain. Patients participate in a stress management exercise, and are encouraged by long term MHCS auxiliary volunteers, who are cancer survivors. We Care Weekend, an annual retreat for recently diagnosed patients and families, is promoted and a save the date card is given to the patients. Patients and their support partners learn how Memorial's Cancer Institute offers complimentary, holistic health services to Live Well with Cancer. Hats from the Heart Program Memorial administers the Hats from the Heart program which provides hats to cancer patients who have lost their hair during their cancer treatment. Private donations of new hats and financial support fund this program which is available in several community cancer treatment facilities. Capital Projects Funding The Foundation was able to fund several capital projects in 2010 that would not have been possible without Foundation donations due to capital restrictions. Funding was provided for a EBUS ultrasound, tube system, mobile van upgrade, ICU waiting room furniture, physicians lounge, and other capital equipment. None of these items would have been acquired without the Foundation funding of \$823 thousand. Contributions Memorial Health Care System Foundation helps support all the programs highlighted above from donations they receive. Memorial Hospital is more able to fund research and education, capital expansion, new equipment and renovation, indigent care, and operating cost for programs that would otherwise not be possible based on the support it receives from the Foundation. The value of this community support is returned to the community through lower costs in patient care programs and community services described throughout this document.</p>
