None of these items would have been acquired without the Foundation funding of \$823 thousand.</p> <p>Contributions Memorial Health Care System Foundation helps support all the programs highlighted above from donations they receive. Memorial Hospital is more able to fund research and education, capital expansion, new equipment and renovation, indigent care, and operating cost for programs that would otherwise not be possible based on the support it receives from the Foundation.
