The Gillham Foundation Grant Procedures

The following are the procedures The Gillham Foundation (the "Foundation") will undertake for awarding grants and for ascertaining that such grants are used for the proper purpose:

1. Grants in the amount of \$1,000.00 - \$3,000.00 per academic year will be awarded to 3-6 deserving students to attend a trade school, college or university.
2. The selection of the individual grant recipient will be made annually by a selection committee consisting of at least three (3) individuals, all of whom are totally independent and separate from the Foundation, its creator, and any disqualified persons with respect to the Foundation. Grants will be awarded solely in the order recommended by the selection committee.
3. The grants must be used for study at the trade school, college or university approved by the committee and must be used for a course of study related to historic preservation, the study of history and/or building trades in related areas. The trade school, college or university must qualify as an educational institution as defined in §170(b)(1)(A)(ii) of the Internal Revenue Code.
4. Selection of grant recipients must be based on prior academic performance, performance on tests, recommendations, financial need, and conclusions drawn from personal interviews by members of the selection committee as to motivation and character. There shall be no discrimination based upon race, color, creed, religion or sex.
5. Prior recipients may re-apply in subsequent years.
6. There will be no basis, restrictions or limitations based upon the employment status of a prospective recipient or any relative of the prospective recipient.
7. The following persons are not eligible to receive scholarship assistance: (a) the members and the relatives of members of the selection committee; and (b) spouses, children, descendants, spouses of descendants, or other persons related to any officers or directors of The Gillham Foundation.
