Summer on the Hill (SOH), a year-round, supplemental academic program, has a mission  
to enrich the education of promising, low-income public school students from the  
Bronx, Washington Heights, and Harlem, prepare them for selective schools and  
colleges, and offer guidance to their parents. SOH is a unique NYC program that  
enrolls promising students at the elementary level and works with them through high  
school -- for as long as ten years. Each year, SOH provides 250 students with  
accelerated academic classes, school and college test prep classes, instruction in  
the arts and sports, and individual guidance on school and college choices.

Since its establishment in 1994, SOH has served 875 public school students and their  
families. SOH has placed 97% of its 2004-2010 high school graduates (185 students)  
in over 90 colleges and universities. SOH encourages students to develop high

greatest strengths is an experienced, dedicated faculty, drawn from local independent, parochial, and public schools, to teach small classes of 12-18 students. Most faculty members hold graduate degrees.

All 5th and 8th graders (and their parents) receive individual guidance on school choices. SOH's Dean of Students is available to meet with parents to resolve behavior or academic concerns.

The High School Program, open only to alumni of the Grade 3-8 program, provides 50+ students with free SAT classes in math and language arts, and a writing workshop on 18 Saturdays during the academic year. The Program Director takes students on day and overnight college trips. SOH also offers individual college counseling and holds four yearly college admissions workshops on such topics as writing the college essay and financial aid. Each year, SOH selects and trains 25+ high school students interested in working with children to participate in the Mentor Internship program, in which they serve as mentors to the children in the summer Grade 3-8 program, under supervision.

Students and families are very enthusiastic about SOH. Grade 3-8 students maintain a 90% average attendance rate during the academic year Saturday program, although Saturday is a sixth day of school. High school students volunteer to serve as mentors to younger children in the summer or to help out in the office during the school year. In addition to academics and guidance, SOH gives students the opportunity to make friendships with like-minded peers from different public schools. These friendships are important to our students, as they may not have friends with similar education goals in their schools. Indeed, students say that SOH

\*Attendance: Grade 3-8 students have a 90% Saturday program attendance rate; 25% or more have 100% attendance. SOH's attrition rate is approximately 6% yearly.

\*Middle School Placement: SOH has placed over 100 students at such independent schools as the George Jackson Academy, the De La Salle Academy, Horace Mann, and Riverdale.

\*High School Placement: SOH 8th graders regularly win acceptance to such selective schools as Bronx Science, Fordham Prep, Horace Mann, HS for American Studies, and LaGuardia.

\*College Placement: 97% (185 students) of SOH's 2004-2010 high school graduates have matriculated in over 90 institutions, including six Ivy League universities and MIT.

\*Awards: Dr. John McIvor, SOH Executive Director, received the 2009 Lewis Hine Distinguished Service Award for increasing opportunities for low-income youth.
