- (a) As of June 30, 2010, the Series 2004 bonds are comprised \$2,370,000 Term Bonds. The Term Bonds bear interest at 4.25% and mature on November 1, 2013. Interest is payable semi-annually on May 1 and November 1 of each year until the principal amount of the bonds are paid.
- (b) As of June 30, 2010, the Series 2006 bonds are comprised of \$6,500,000 Serial Bonds maturing annually through March 2018. The annual maturities on the Serial Bonds range from \$675,000 to \$935,000 and the interest rates range from 3.85% for those maturing in fiscal year 2009 to 4.6% for those maturing in fiscal year 2018. Interest is payable semi-annually on March 1 and September 1 of each year until the principal amount of the bonds are paid.
- (c) As of June 30, 2010, the Series 2009 bonds are comprised of \$2,845,000 Serial Bonds and \$11,280,000 Term Bonds. The Serial Bonds mature annually beginning March 2013 from \$270,000 to \$370,000 and bear interest rates from 4.00% for those maturing in fiscal year 2013 to 5.00% for those maturing in fiscal year 2021. The Term Bonds mature from March 1, 2027 through March 1, 2039 and bear interest rates ranging from 5.00% for those maturing in 2027 to 5.75% for those maturing in 2039. Interest only payments are due through March 1, 2013 and interest is payable semi-annually on March 1 and September 1 of each year until the principal amount of the bonds are paid.
