Home Instruction for Parents of Preschool Youngsters (HIPPY) is a home-based early childhood education program that actively engages parents in teaching age and developmentally appropriate learning activities to their three and four year old children. HIPPY recognizes the important role parents play in their child’s early learning experiences and provides in-home parenting support, as well as, parent group meetings that enable them to acquire needed skills, and confidence to teach their child. For the program year 2009/2010 there was a total of 248 children served by this program.

Statement 2 – Form 990, Part III, Line 4b – Statement of Organization’s Program Service

Jonesboro Urban Renewal and Housing Authority Housing Community Development Organization is a HUD-Approved Housing Counseling Agency that provides the following services: Mortgage Delinquency and Default Resolution Counseling, Fair Housing Assistance, Homebuyer Education Programs, Loss Mitigation, Money/Debt Management, Pre-Purchase Counseling, Post-Purchase Counseling, Predatory Lending and Renters Assistance counseling services.

We have served 292 clients with the following results. 93 clients completed Homebuyer Education workshops (8 hours) and received certificates that enabled them to access down-payments assistance programs in this area. 191 clients received pre-purchase one-on-one services that resulted in 62 clients becoming new homeowners, 68 mortgage ready within 90 days, 10 within 90-180 days, 48 receiving long term(>180 days) counseling, 2 clients decided not to purchase, and 1 withdrew from counseling. All of the clients who attended the workshops and received pre-purchase counseling received counseling in the area of budgeting, money management, and credit counseling services.
