Community Service programs are programs to assist families with budget counseling, information, education referrals and emergency assistance. The funding assists low-income persons in the community with childcare, health and human services for children, families and the elderly, housing and other poverty-related programs. This program served 16,801 individuals and 5,602 families during the year.

(Code) (Expenses \$ 9,626,099 including grants of \$ 8,575,899) (Revenue \$)

Child Care Management services provides expanded child care services for eligible families. The organization serves seventeen counties and is responsible for administering all Texas Workforce Commission Child Care funds including vendor recruitment, training and monitoring, client intake, eligibility verification and assistance in making child care arrangements to providers for self-arranged care. This program served 5,499 individuals and families during the year.

Head Start and Early Head Start are comprehensive child development programs serving children from birth to 5 years old. The goals are to increase the social competency of young children, improve the overall health of the children, provide a productive learning environment, and assist families to identify strengths, needs and interests in order to meet their goals. The programs also identify nutritional needs of the children and provide them with healthy meals. This program served 571 children during the year.
