Homeless Services Center provides emergency and transitional services to homeless individuals in the County of Santa Cruz. Homeless Services Center has four main programs including the Day Resource Center; Rebele Family Shelter; Page Smith Community House; Paul Lee Loft and Winter Shelter. During the period of July 1, 2009 through June 30, 2010 the Day Resource Center provided a total of 136,025 meals to homeless individuals and 23,848 showers and laundry facilities. The FSET (Food Stamp and Employment Training) program enrolled 456 clients to assist in finding employment. The Paul Lee Loft and Winter Shelter Program is an overnight emergency shelter that provided 24,770 "bed nights" during the stated time period. The Rebele Family Shelter had 47 families residing in the shelter that received case management and employment and housing assistance. The success rate of families moving out of the shelter and into permanent housing during the time period was 94% (44 families out of 47). The Page Smith Community House had a total of 56 individuals residing in the transitional housing program.
