FCE HAS DEVELOPED A COMPREHENSIVE COLLEGE RETENTION PROGRAM TO SUPPORT AND GUIDE FCE STUDENTS TO ENSURE THAT THEY OBTAIN A BACHELOR'S DEGREE. ONE HUNDRED PERCENT OF FCE'S STUDENTS GRADUATE FROM HIGH SCHOOL AND ENROLL IN POST-SECONDARY INSTITUTIONS. EIGHTY-FIVE PERCENT OF FCE COLLEGE STUDENTS COMPLETE COLLEGE WITHIN FIVE YEARS.

SCHOLARSHIP PROGRAM -STUDENTS FROM FAMILIES IN THE HIGHEST INCOME BRACKET ARE 5 TIMES MORE LIKELY TO RECEIVE A BACHELOR'S DEGREE BY AGE 24 THAN THOSE FROM THE LOWEST INCOME BRACKET. INSTITUTIONAL BUDGET CUTS HAVE LIMITED THE RESOURCES AVAILABLE FOR FINANCIAL AID. MANY SCHOOLS CAN'T MEET THE DEMONSTRATED FINANCIAL NEEDS OF LOW INCOME STUDENTS. STUDIES HAVE SHOWN THAT COLLEGE STUDENTS WITH HIGH FINANCIAL NEED MUST UNDERTAKE EXTRAORDINARY EFFORTS TO COMPENSATE: LIVING OFF-CAMPUS, WORKING LONG HOURS WHILE IN SCHOOL, AND INCURRING CONSIDERABLE DEBT. ALL THESE MEASURES DETRACT FROM THE COLLEGE EXPERIENCE AND THREATEN DEGREE COMPLETION. FCE'S COLLEGE SCHOLARSHIP PROGRAM HELPS ADDRESS THE GREATER FINANCIAL NEEDS OF ITS STUDENTS PROVIDING SUSTAINABILITY GRANTS AND HENCE, PLAYS A KEY ROLE IN RETENTION.
