Schedule C, Part II-B, Line 1: Our primary activities during the reporting period focused on education of legislators about the diverse racial, ethnic, linguistic, cultural, religious and immigration experience of Oregon's Asian and Pacific Islander communities. Nearly all of our direct contact with state legislators was conducted by volunteers, with very limited staff support to coordinate logistics. Other activities included ballot measure campaign work, and meeting with state legislators about their proposed bills for the 2011 state legislative session. Two 30 minute educational visits by community volunteers on behalf of health equity in federal health care reform with offices of Sen. Jeff Merkley, Rep. David Wu, promoting racial equity measures. Staff coordinated our message with coalition partners, organized volunteers to participate, and facilitated debrief of the visit. We met with staff members in coalition with other community based organizations working in communities of color. One letter of support for federal health care reform sent to Oregon federal delegation signed by community leaders. Staff recruited community leaders to sign-on and managed the final editing and distribution of the letter. 20 hours of phone banking in support of statewide ballot measures 66 and 67. One 60 minute ballot party training advocating Yes on 66 and 67. Staff coordinated the phone bank and ballot party training with over 40 volunteers. One lobby day during Oregon state legislative special session

with 20 volunteers who met with 10 different state legislators. Our primary purpose was to introduce community members to the legislative process and introduce them to their local legislator. Staff coordinated the travel and meal logistics, print materials, and appointments with legislators. Volunteers conducted the meetings with legislators.
