Outreach and educational activities associated with the production of "II Trovatore" included: A field trip to the performance venue for 5th and 7th graders. The students were introduced to the behind-the-scenes components of producing an opera. Approximately 500 students attended. In collaboration with the public school music department a study guide was developed and distributed prior to this field trip. Retired opera singer, Suzanne Gorder presented a two part community workshop on May 1st and 8th to approximately 40 attendees demonstrating excerpts from "II Trovatore" along with history of the opera and of the composer and synopsis of the plot. A continuing education component of Montana State University "Wonderlust" held an opera class on May 7th with 65 attendees, with presentations given by the Artistic Director, Conductor, Director and Stage Manager.
