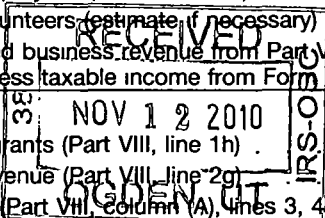

190 adults (16 and older and not enrolled in school) received direct literacy instruction to enable them to function on the job, in their families, and in society. 31 students completed their high school equivalency diploma, or GED. Nine students enrolled in post-secondary education or training.
Explanation of grants: 22 students received a grant of \$55 to pay for the GED testing fee. The checks are made out to the test center, and not to the individual, so they cannot be used for any other purpose. We also paid for one SAT testing fee (\$32), and one ACT testing fee (\$45). One student received a college scholarship of \$1,000. The check was made out to the college, not the student.

English Language/Civics instruction for 15 adults seeking to speak English better and to become participants in the community or gain citizenship.

Family Literacy activities included: workshops for 17 parents of preschool children, story times for more than 300 children, and 349 new books distributed to needy children. Most of the staffing on this project was volunteer.
