The Head Start program provides comprehensive early child development services to economically disadvantaged children and families, with a special focus on helping preschoolers develop the early reading and math skills they need to be successful in school. Our program specifically targets children, birth to 5 years of age, of Migrant & Seasonal Farmworkers. The program has served 802 children and approximately 542 families this program year (May 1, 2010 - Present). The program has been recognized for being one of the first programs to create and implement a dual language policy that supports the preservation of home language and culture of MSHS children and families. It focuses on continual development of home language while promoting the acquisition of English as a means for preparing children and families in their transition into diverse community services and activities. It has also been recognized for the number of children that have been screened for lead. It is well above state and national numbers reported by other programs.

The Employment & Training Department delivers top quality workforce development services to our target participants by providing them the skills and tools necessary for continued career success while meeting the needs of a demand driven economy with the ultimate goal of obtaining employment. Services include career counseling, on-the-job training, occupational skills training, work experience and job stabilization services. Over the past year more than 4,784 individuals have benefited from our services.

The housing program provides low income farmworkers with affordable housing. With seven multi-family communities, we are a major developer of affordable housing. These units are located throughout the state of Idaho to serve the needs of migrant and seasonal farmworkers and their families. We also provide transitional services to homeless and single individuals, homeless families, and other housing needs of rural communities.
