# The Logan School for Creative Learning Scholarship Award Process and Procedures

## Availability of Funds

Scholarship funds are made available from three sources

1. A fixed percentage of assessed tuition is allocated to scholarships. The Board of Trustees sets this during the budget process (currently 7.5% of base tuition)
2. Designated gifts for scholarships. These may be given to the general fund or may be given with a recommended recipient.
3. Revenue generated from the financial aid endowment

## Application Process

Upon a student's acceptance into the School, those applying for scholarships must complete the following.

1. A "School and Student Service for Financial Aid" application provided by the Educational Testing Services (ETS). This application is submitted for analysis to ETS and is returned with a financial evaluation of the applicant's ability to pay for the child's education. Fee waivers are available to families who meet certain income guidelines.
2. Submit to the Committee a completed copy of year's tax return with a photocopy of the SSS application form. This information is used directly by the scholarship committee

## Assessment and Award Process

### The Scholarship Committee

The Logan School scholarship committee is comprised of the Head of School, Director of Admission and Director of Finance and Operations. It is the prerogative of the scholarship committee to invite other Logan members to assist with this task.

### Timing

The primary distributions of the scholarship funds are made in the March. To be considered at this time, both forms of information described must be completed and the SSS analysis must have been received from ETS. Special needs may be evaluated during other times of the year on a case-by-case basis.

### Evaluation Procedures

The evaluation and financial award process take into consideration a number of factors. The committee uses the following general guidelines:

1. The awards are based on financial need. The ability to pay tuition is assessed from the financial data supplied on the application forms, the ETS analysis, and any descriptive comments or special situations that are expressed by the applicant.
2. In most cases, the maximum award will be 85% of the tuition, however, special exceptions may be made by the Financial Aid Committee.

3. Subjective factors, such as use of discretionary income, are taken into consideration.
4. The total amount of awards cannot exceed the budgeted amount of available scholarships.
5. All submitted data and the resulting awards are kept confidential.

### Notification and Appeal

Applicants are notified of the committee's decision by letter. Applicants may ask the committee to reconsider its decision with a written request.

### Change of Status

Scholarships are awarded based on the applicant's financial projections for the coming year. If these projections change substantially during the year so that the applicant is better or worse off than anticipated (typically a 10% or greater change), the applicant must resubmit their application for review by the committee. At the committee's discretion, the award amount may be reduced or increased for the balance of the school year.
