	Resource Center - Direct ServicesDirect Services is here for those in need when there is no place else to turn Our food pantry, clothing bank, and warehouse facilities make Springs Rescue Mission El Paso County’s largest provider of life's essential items Direct Services is strategically networked to provide the right help as quickly as possible through our extensive partnerships with other local agencies In an effort to not duplicate services, SRM focuses on areas that will create impact in the lives of the impoverished in our community in the area of basic living needs In fiscal year 2010 we assisted almost 50,000 clients through Direct Services Over 83 tons of clothing were provided and over 3,700 furniture items were distributed We were able to give over 10,000 coats to children and families, as well as approximately 1,800 sleeping bags and blankets to the homeless, over 2,200 hygiene packs, over 2,600 baby items to families and individuals in need in the community Through our Back-to-School drive, we supplied students with 1,000 backpacks, 715 of which were filled with school supplies SRM gave over 3,800 TEFAP food boxes (The Emergency Food Assistance Program created by the government to help feed low-income families), almost 1,300 emergency food boxes to families and homeless people in the community, and over 1,000 Bibles

	Samaritan's Kitchen - Meals & Food ProgramOur meal program provides hot meals six days a week to those in need in a cafeteria style facility For fiscal 2009, the Samaritan's Kitchen provided 47,547 meals in our community and an additional 229,390 meals through food boxes Total food distributed through SRM to the local community was an astounding 179 tons of food SRM hosted numerous events on and off site to feed those in need in our community including "The Best Christmas Ever" event at the Colorado Springs City Auditorium, Thanksgiving and Easter dinners at the mission, a Fall Extravaganza, and our Back to School event The meal programs are at the core of our purpose for the Springs Rescue Mission Providing a meal and a bit of hope can be an avenue to lasting change for those who are hurting In collaboration with other agencies, SRM’s Kids Cafe summer lunch program we provided and delivered more than 24,000 nutritional lunches, 10,172 meals for patients in addiction recovery and delivered 6,240 additional meals to clients located at an offsite facility

	Recovery Programs - New Life Program Springs Rescue Mission currently provides a 12-18 month residential recovery program for men suffering from addictions, including chronic alcoholism and drug addiction Plans are in motion to expand the recovery program to include women with addictions, and to offer families assistance and counseling SRM comes alongside men on their journey from dysfunction and addiction to new life based on relationship with Jesus Christ They learn accountability and trust in a safe environment so they can fight their addictions and other self-destructive tendencies The New Life Program focuses on recovery and healing for broken men Through drug and alcohol recovery, intensive counseling, job training and education, these men learn how to live free of substance abuse, maintain healthy relationships, and hold a permanent job In fiscal 2009 we provided over 12,000 bed nights through the New Life Program Collaborative relationship with partnering agencies and churches continue to strengthen our ability to provide solid exit plans, mentors, housing, and jobs, as graduates move into aftercare

Culinary Arts Training Expansion Men involved in the New Life Program are now able to gain more intensive culinary training skills Since 2004, Springs Rescue Mission has offered a 6-month course certified by the American Culinary Federation In 2009, we expanded the training to an optional additional 18-month course offered in concert with Pikes Peak Community College Course participants pursue a career in professional cooking and hospitality as they learn the skills necessary to pursue sustainable employment in the food service industry Graduates are awarded American Culinary Federation certificates upon completion As a result, New Life Program participants gain highly marketable skills and learn the standards required in todays restaurant and culinary industry In addition, all food prepared throughout the course feeds those who are seeking help at Springs Rescue Mission Career Advancement Center We currently have eight tutors coming alongside our men weekly These tutors, along with our improved GED educational software, provided training and assistance to NLP residents who were preparing for their GED tests last year We also have 15 volunteer teachers, and six staff members teaching Bible classes and life skills training daily With the continued implementation of Level 4 Career Employment Life Skills Program, a 13-week program consisting of classroom engagement and individual job search coaching, another 21 men have successfully completed the training in fiscal 2009 Volunteer ProgramAs referenced in the opening statement Springs Rescue Mission is called to partner with, empower, and equip the local church and community in service We are beginning to put into action our volunteer program with the opening of our new Volunteer Center We have launched one of the biggest volunteer programs impacting the community With the unveiling of our new Volunteer Training Center as well as our user-friendly online volunteer database, we will provide additional volunteer opportunities for daily service, fund raising, and events The Volunteer Center will connect gifted people with one another in transformational and relational ministry experiences
