Organization solitcits, collects, purchases food and grocery ites which it distributes to various non profit agencies such as soup kitchens, food pantries, shelter, and commodities sites in six counties. Distributions to agencies serving the needy, elderly, children, and ill in six counties. During the current year, we distributed about 1,281,300 pounds of food and household necessities.

4b (Code) (Expenses \$ **64,197** including grants of \$) (Revenue \$)
Organization served an average of 320 low income students each weekend during the 2009-2010 school year. Schools were also encouraged to distribute emergency food boxes to families with short term financial crises. Total food provided was about 43,500 pounds.

4c (Code) (Expenses \$ **1,813,695** including grants of \$) (Revenue \$)
Organization served an average of 87 homebound residents with limitations such as age, poor health, and limited income. Food was delivered to each household by volunteers or agencies. Total food distributed was about 29900 pounds. If desired by recipient, a daily phone call was also made.
